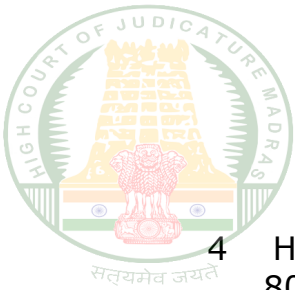

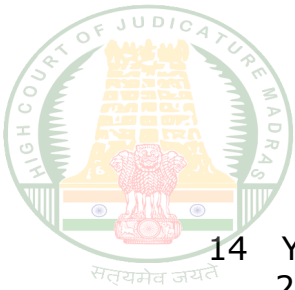

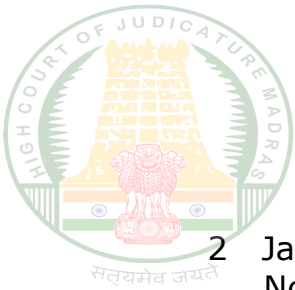

COMMON ORDER

In a suit seeking remedies in respect of apprehended infringement of the plaintiff's copyright, in the cinematographic film HAPPY PATEL KHATARNAK JASOOS, the plaintiff has presented two applications seeking interim relief against the internet service providers and cable TV operators, who are arrayed as respondents in the respective applications.

2. As *prima facie* evidence of the plaintiff's ownership of copyright, the plaintiff has submitted the CBFC certificate mentioning the name of the plaintiff as the producer. The promotional material reveals that the movie is slated for release on 16.01.2026.

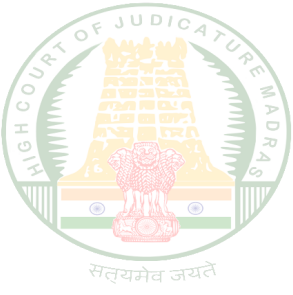
3. In matters of this nature, it is likely that irreparable injury would be caused unless ad interim relief is granted. At the same time, in view of the expansive nature of the relief claimed, it is possible that the legitimate business interest of one or more respondents may be affected. Therefore, the plaintiff shall indemnify in respect thereof.

4. Subject to the above condition, orders of ad interim injunction as prayed for are granted until 02.02.2026. Issue notice to the respondents returnable on 02.02.2026. Private notice is also permitted. The applicant shall comply with Order XXXIX Rule 3 CPC.
