ORDER

1. It is seen that though an Application for substituted service by Newspaper publication is filed, the name of the Newspaper and the Edition in which the publication is sought are not shown. The appellant is directed to file a Memo showing the name of the Newspaper and Edition in which the publication is required.
2. In several cases it is seen that Applications for substituted service by Newspaper Publication is filed without showing the name of the Newspaper and the Edition in which the publication is sought. Hence the Registry is directed to ensure that in all Applications for substituted service by Newspaper Publication, the name of the Newspaper and the Edition in which the publication is sought are stated, before numbering those Applications.
