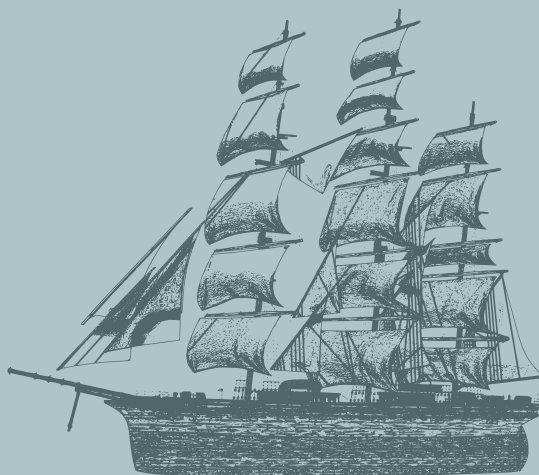

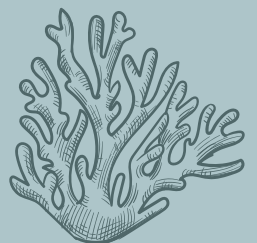
ABOUT THE COURSE

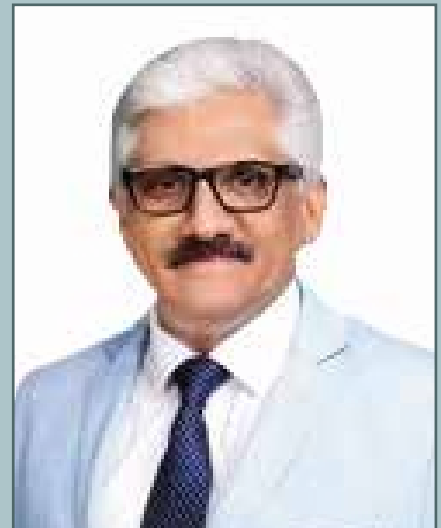
