O R D E R

I.A NO. 3234/2022 IN WP (CRL.) NO. 295/2020

The grievance in this application is limited to no progress made in the hearing of the writ petition pending

before the High Court, despite a sanguine hope expressed in the previous order passed by this Court in that regard.

It is reported that the Union of India is taking unnecessary adjournments. Instead of examining this plea in the present order, we deem it appropriate to dispose of this application with liberty to the applicant to invite the attention of the Hon'ble the Chief Justice of the Patna High Court whilst requesting expeditious hearing of the writ petition, in terms of order dated 25.03.2021 passed by this Court.

We hope and trust that the High Court will be in a position to deal with the stated grievance appropriately, including to dispose of the writ petition.

The application is disposed of accordingly.

As regards the main matter, as important and short question is involved, which needs to be addressed expeditiously, we direct the listing of the main matter in the second week of March, 2022 on a non-miscellaneous day.
