COMMON ORDER

(Order of the Court was made by **DR.G.JAYACHANDRAN.,J**)

The General Secretary of Hindu Munnani, Madurai City had approached the Inspector of Police, Thiruparakundram seeking permission to conduct

demonstration on 4.2.2025 between 3.00 p.m. to 9.45 p.m. near 16 Kal Mandapam in connection with alleged encroachment of the temple land and the inaction by the Police against the encroachers.

2. The permission sought for was declined by the Assistant Commissioner of Police vide proceedings in Na.Ka.No.10/Camp/ACP/Law and Order/2025, dated 2.2.2025. Consequent to this, the respondent Police has released a press note informing the general public not to come to Thiruparankundram temple on 4.2.2025. Also fleet owners and transport operators are warned not to facilitate transport of public to Thiruparankundram temple enabling them to participate in the protest. The District Collector on the opinion given by the Commissioner of Police has passed a prohibitory order for two days covering 3rd and 4th of February 2025, Being aggrieved, batch of Writ Petitions have been filed and taken up together for consideration.

3. The main contention on the side of the Petitioners is that the rejection order was passed in the last minute and communicated only day before yesterday. On the side of the State, it is represented that under the guise of protest and

expressing their anguish and dissatisfaction by the order issued by the police, the petitioners creating disharmony between communities.

4.This Court after giving anxious consideration of the rival submissions made on either side is of the view that the right of expression should always be subject to public peace and other restrictions imposed by the Constitution. On the other hand, regarding impugned orders, this Court is of the opinion that the issue could have been handled in a better way. However, fortunately, with the able assistance of the learned Public Prosecutor and the learned Additional Advocate Generals, it has now been by consensus, the issue is substantially diffused and the organizers agreed to carry out their demonstration/protest at Pazhanganatham junction instead of Thirupparankundram temple 16 Kal Mandapam, which will avoid inconvenience to the devotees. The respondent Police agreed to provide proper arrangement and protection for the demonstration at Pazhanganatham junction between 5.00 p.m. to 6.00 p.m. today. The demonstrators shall not carry more than one mega phone and protest must be peaceful. No provocative slogans shall be raised which may cause disturbance to the public peace and tranquility. The agitation should be fully video-graphed. The organizers should permit the

Police to video-graph the agitation without any interference or protest. The Writ
Petitioners are to be responsible for the peaceful conduct of demonstration as
afore-stated.

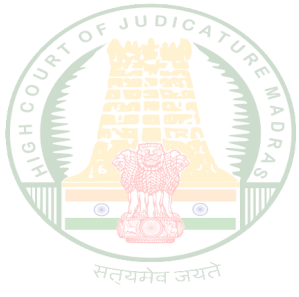

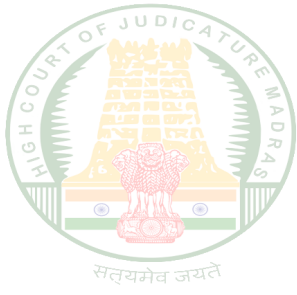
