**HON'BLE SAMEER JAIN, J.**

1. Heard Sri G.S.Chaturvedi, learned Senior Advocate, assisted by Sri Zeeshan Mazhar, learned counsel for the applicant and Sri Arvind Kumar, learned AGA, for the State.

2. At the very outset learned senior counsel appearing on behalf of the applicant submits that applicant is sitting MLA and on the basis of false allegation he has been made accused in the present matter.

3. He further submits that it is an unfortunate case in which the maid servant of the applicant committed suicide and applicant along with his wife has been made accused in the present matter and without any proper investigation charge sheet has been filed against the applicant and his wife for offence punishable under Section 108 BNS although prima facie offence under Section 108 BNS is not made out.

4. He further submits that wife of the applicant, namely, Seema Beg filed Separate Application U/s 528 BNSS No. 34969 of 2025 and after considering entire material available on record this Court was pleased to call counter affidavit.

5. He further submits that instant application may be connected with the application filed by wife of the applicant so as both the application may be simultaneously heard and disposed of and in the meantime, applicant may also be protected.

6. Per contra, learned AGA although opposed the prayer but could not

dispute the argument on facts advanced by the learned counsel for the applicant.

7. Considering the argument advanced by learned senior counsel appearing on behalf of the applicant and after perusing the order dated 16.9.2025 passed in Application U/S 528 BNSS No. 34969 of 2025 filed by the wife of applicant, in view of this Court, matter requires consideration.

8. As FIR of the present case has been lodged by Sub Inspector, therefore, there is no need to issue separate notice to him as State has already received the notice.

9. Connect the instant applicant with Application U/S 528 BNSS No.34969 of 2025.

10. List this case along with the connected matter on 28.10.2025 amongst top ten cases in the category of daily cause list.

11. In the meantime, State may file counter affidavit.

12. Till the next date of listing, further proceedings of Session Trial No.34 of 2025 (State Vs. Zahid Beg @ Zahid Jamal Beg & another) arising out of Case Crime No.188 of 2024, under Section 108 BNS, Police Station Bhadohi, District Bhadohi pending in the court of Special Judge(M.P./M.L.A.)/Additional Session Judge Ist Bhadohi Gyanpur shall remain stayed with respect to applicant.
