GNLU NATIONAL LEGAL IDEATHON

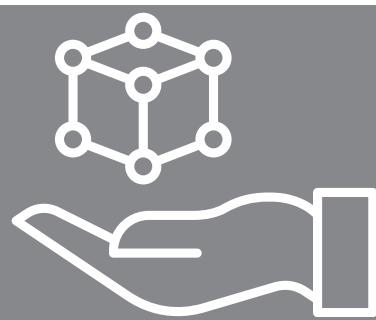

IDEATION



Participants are encouraged to creatively propose solutions, showcasing their problem-solving skills, critical thinking abilities, and ability to identify and address emerging legal challenges in the ideation category.



PROTOTYPE

This category often involves utilizing technology and interdisciplinary methods to create innovative tools, platforms, or applications that enhance legal processes, justice access, and service efficiency.



ELIGIBILITY



WHO CAN PARTICIPATE?

- Age Limit: 16 years and Above.
- Students from various universities and colleges can participate in the Ideathon.
- This includes both undergraduate and postgraduate students.
- The Team composition of Minimum 2 & Maximum 3 participants is permitted.

SUBMISSION CRITERIA

- All submissions must present novel and innovative ideas. Any indication of plagiarism or replication will result in immediate disqualification.
- Proposed startup concepts must directly address the designated problem areas strictly within the legal domain, in alignment with the event's specified theme.
- Participation is open to students enrolled in any academic discipline or program.
