Learned counsel for the petitioners contends that though the

order was passed on 05.02.2021 and 12.02.2021 granting bail to the concerned respondents, what has been placed on record is only the operative portion of the order as till date the main order has not been uploaded. In this behalf, learned counsel has drawn our attention to the order of this Court to the undesirability of such practice as observed in *Balaji Baliram Mupade & Anr. v. State of Maharashtra & Ors.* – AIR 2020 SC 5758.

On merits, it is submitted that the respondents did not join the investigation and were absconding till they were taken into custody as per the order of the High Court and despite that bail has been granted at this stage.

Our attention has also been drawn to the role played by them as per the supplementary charge sheet filed in the additional documents.
