ON 23.04.2020 (TELEPHONICALLY) HAS LAID DOWN THE
FOLLOWING CONDITIONS/GUIDELINES FOR GIVING FINANCIAL
ASSISTANCE TO THE NEEDY AND INDIGENT ADVOCATES DURING
THE LOCKDOWN DUE TO COVID-19 :-**

1. The applicant must be enrolled with the Bar Council of Rajasthan.
2. The applicant is in real and active legal practitioner at the Bar as on the relevant date.
3. Advocates/Applicants are required to pass AIBE mandatorily within stipulated period and must enclose/refer passing acknowledgement.
4. Applicants should have submitted Certificate and Place of Practice under Certificate of Practice Rules, 2015.
5. The applicant is not receiving any monthly payment from the Advocate to whom he/she is junior, as certified by his/her Senior Lawyers.
6. The applicant was not earning monthly income Rs.10,000/- as on the relevant date.
7. The applicant is finding himself in great difficulty for his/her livelihood or for purchase of medicine or regular treatment due to extraordinary situation.
8. If Advocate/Applicant is residing in the rented accommodation, he/she should be submitted a rent agreement or self attested affidavit.
9. The spouse of the applicant should not been an employee.
10. Advocate-applicant/applicant's spouse should not have either immovable properties and four wheeler.
11. Advocates enrolled after retirement from any service are not eligible.
12. Income Tax Assessses are not eligible under this Scheme.
13. The Executive Committee of the concerned Bar Association shall constitute a Committee consisting of President and Secretary of the Bar and Three Advocates (not less than 20 years of practice in the Bar). The Committee shall scrutinized all the applications and prepare the merit list and send the same to the Bar Council

of India Advocates Welfare Fund Committee for the State of Rajasthan for further consideration. At a place, where the Advocates practicing not less 20 years, is/are not available, in such a situation, the Senior most Members of the Bar may be included in the aforesaid Committee.

14. If any applicant furnished false particulars to avail the benefits, the Bar Council will initiate disciplinary action against such person under section 35 of the Advocates Act, 1961, in addition to recovery of the amount with penalty as determined by the Committee.
15. On receipt of application through Bar Association, the Bar Council of India Advocates Welfare Fund Committee for the State of Rajasthan shall decide the application and eligible applicant will be provided financial assistance of Rs.5,000/- (Rs. Five Thousand only).
16. The financial assistance of Rs.5,000/- (Rs. Five Thousand only) sanctioned by the Committee will be credited directly to the accounts of needy advocates found eligible.
17. All the applications must reach in the office of the Bar Council of Rajasthan through e-mail at **secretary@barcouncilofrajasthan.org** upto 3rd of May, 2020 positively. No application will be entertained after the receipt of last date.
