1. Preliminary objection has been raised by learned counsel for the defendants that the plaint has been incorrectly valued and appropriate Court fees has not been paid.

2. Mr. Dubey, the plaintiff, who appears in person, undertakes that he shall pay the requisite *ad valorem* Court fees on the plaint as per the valuation of the Suit for the purposes of jurisdiction mentioned in

paragraph 41 of the plaint.

3. Subject to plaintiff paying the requisite Court fees within a period of four weeks from the lifting of the lockdown, plaint be registered as a Suit.

4. Issue Summons. Notice is accepted by Mr. Thomas George, Advocate for defendant Nos. 1 & 2; Mr. Hiren Kamod, Advocate accepts notice on behalf of defendant Nos.3, 6 & 7; Mr. Piyush Joshi, Advocate accepts notice on behalf of defendant No.4 and Ms. Priyanka Khimani, Advocate accepts notice on behalf of defendant No. 5.

5. Written statement be filed within the statutory period. Replication, if any, within four weeks thereafter.

6. List before the concerned Joint Registrar for completion of pleadings on 07.07.2020.

IA No. 3755/2020 (exemption)

Allowed, subject to all just exceptions.

IA No.3756/2020 (for enlargement of time to pay Court fees)

In view of the order passed in the Suit, application is disposed of.
