of court proceedings

Sir,

It is to inform your good self that an unprecedented situation has been created in the last few days as it was reported that an Advocate who can come to the High Court of Manipur and argued a case in Court No.2 on 10/09/2020 and 11/09/2020 has been found to be COVID 19 positive. As a precautionary measure all the employees have been tested today and the result of the tests are awaited.

If Court work is to continue in the normal manner it would pose a great risk to the lives of the Advocates, litigants and employees of the High Court.

The Health Department, Government of Manipur has also advised to take precautionary measures till the test results have arrived.

In view of the unprecedented situation and also considering the advice of the Health Department, on behalf of the members of the Bar, it is requested to appraise the Hon'ble Chief Justice of the High Court of Manipur about the grave situation and to request His Lordship to kindly adjourn Court proceedings for at least one week.
