Application for permission to file special leave petition is allowed.

Issue notice.

Dasti service, in addition, is permitted.

Shri Harin P. Raval, learned senior counsel, appears for respondent no.7, the petitioner in the writ petition before the High Court.

Learned counsel for the petitioners is permitted to serve a copy of this petition to the standing counsel for the State of Jharkhand.

Looking to the nature of issues raised in this special leave petition, we are of the view that matter needs early consideration by this Court. We, thus, fix this matter for 04.11.2020.

Two weeks' time is granted to file counter affidavit. Rejoinder affidavit, if any, be filed before the next date of hearing.

In the meantime, those teachers, who are working in the scheduled District shall continue to work and shall not be displaced in pursuance of the impugned judgment of the High Court.

Interim relief till the next date of hearing.

We permit the applicants to intervene in the matter. Affidavit, if any, also be filed by the intervenor within two weeks. I.A. No.104625/2020 is disposed of.
