JUDGMENT

The polling day is the day on which a voter use his powerful tool that can make and break an elected body in a democracy. It should not be a day of war, but it should be a day of peace. Mahatma Gandhi said that “The ballot is the most powerful nonviolent tool to a citizen in a democratic country.” But the petitioners in these Writ Petitions apprehend law and order problem on the polling day.

2. All these Writ Petitions are filed with a common grievance. The General Election - 2025 to the local bodies is scheduled to be conducted on 9th and 11th of December, 2025 in Kerala. The petitioners in these Writ Petitions apprehend that there will be law and order problem in the area mentioned in each of these Writ Petitions on the date of polling to sabotage the election. It is also the case of

the petitioners that, in some of the polling booths, on earlier occasions, there was booth capturing and other law and order problem. Therefore, a web casting or videography is necessary in those polling booths, is the contention raised by the petitioners in some of these Writ Petitions. There is a prayer for deployment of additional police force also. In some of the cases, the candidates contesting in the election and their booth agents apprehend physical assault from their rival party members.

3. The learned Government Pleader after getting instructions submitted that the State Police Chief made all arrangements to give sufficient protection to all the polling booths in the State for the smooth conduct of the election. Several Writ Petitions are from Kannur District. It is submitted that the Commissioner of Police, Kannur City submitted a report and the same is handed over to this Court. In the report, it is stated that the total booths within Kannur City limit is 1304. It is also stated that the hyper sensitive booths are identified as 132 (divided into 85 cluster). It is further submitted that, as far as hyper

sensitive booths are concerned, live web casting + additional 4 police officers for each cluster is deputed. In Kannur city, 470 booths are identified as sensitive booths. It is submitted that live webcasting + additional one police officer for each such booth has already been allotted. It is also submitted by the Government Pleader that, in the State of Kerala wherever the booths are identified as hyper sensitive booths or sensitive booths by the State Election Commission, the same pattern of arrangement as mentioned above will be made.

4. The learned Standing Counsel appearing for the State Election Commission submitted that, in almost all the Writ Petitions, a statement is filed. The Standing Counsel takes me through paragraph Nos.16 to 18 of the statement filed in W.P.(C) No.45365 of 2025. The same is extracted hereunder:

“16. As far as Nileschwaram Municipality in Kasargod District is concerned, as per report from State Police Chief, it is reported that ‘4 sensitive polling stations’ have been identified; namely, 1) ALP School, Palayi in Ward No. 11 (Palayi), 2) AUP School Chathamath Eastern Side in Ward No. 14

(Poovalamkai), 3) St. Anns UP School Pallikkara Western building (North side) in Ward No. 16 (Karyamkode) and 4) Pallikkara Kanathad Anganwadi in Ward No. 20 (Pallikkara-II) and accordingly live webcasting facility is being arranged in said polling stations. However, as on today, the polling stations in Ward No. 21 of Nileschwaram Municipality have not been identified as vulnerable, sensitive or hyper sensitive polling stations.

17. Maintenance of law and order even during the period of election is a sovereign function, which belongs to the exclusive realm of the State. The State Election Commission on its part has taken all steps for the conduct of a free, fair and peaceful election. The State Election Commission has been informed that all steps are being taken by the police to ensure a free and fair election.

18. Rules 31 to 33 of the Kerala Panchayat Raj (Conduct of Election) Rules, 1995 provides for sufficient safeguards against impersonation at election. As per the provisions under Rule 31 of the Kerala Panchayat Raj (Conduct of Election) Rules, 1995 as amended by Kerala Panchayat Raj (Conduct of Election) Amendment Rules, 2012 the voters will have to produce the electoral identity card issued by the Election Commission of India or other alternative documents prescribed by the State Election Commission for identification. ”

5. The Standing Counsel for the Election Commission also takes me through Ext.R1(a) produced in

the statement. In Ext.R1(a), it is stated that the District Election Officer can order videography at the expense of the contesting candidates wherever they apprehend malpractice and they can file an application to that effect, and the District Election Officer concerned feels that there is basis for such apprehension, they can allow such prayers, after obtaining prior permission from the State Election Commission.

6. After hearing both sides, I think a general direction can be issued in these cases. This Court also considered the dictum laid down by this Court in **Hussain Vengad and Others v. State of Kerala and Others** [2021 (1) KHC 519]. This Court observed in the above judgment that, in election wherein candidates or their election agent have submitted complaints complaining of threat before Police, Superintendent of Police of the area shall take note of threat perceptions and grant protection to candidates and their agents. Other detailed directions were also given by this Court in **Hussain Vengad's** case (supra) in the previous election.

In the light of the above dictum and also in the light of the submissions of the counsel for the petitioners, learned Government Pleader and the learned Standing Counsel appearing for the State Election Commission, these Writ Petitions are disposed of in the following manner:

1. The police authorities and the officers of the State Election Commission will do the needful to see that the General Election - 2025 to the local bodies is smoothly conducted on 9th and 11th of December, 2025.
2. The State Police Chief and the jurisdictional District Police Chief will do the needful for live web casting and for deputing additional police force as mentioned earlier in the booths which are identified by the State Election Commission as hyper sensitive booths and sensitive booths,
3. If any of the petitioners' want videography in any of their polling booths, they can file an

application before the jurisdictional District Election Officer within three days from today.

If such an application is filed, the jurisdictional District Election Officers will allow videography at the expense of the applicants' concerned. If any application is already filed to that effect, the same will be allowed at the expense of the applicants' concerned.

4. The petitioners are free to file appropriate application for police protection to the life of the candidates, their agents etc., before the jurisdictional District Police Chief or Commissioner of Police within three days. If such an application is received, sufficient protection should be given to those persons in accordance with the law.
5. I make it clear that, if there is any law and order problem, the State Police Chief and the District Police Chief concerned will see that

additional police force is deputed to that area. For that purpose, the candidates or its agents can submit appropriate application and if the police officers are convinced about the genuineness of the same, the jurisdictional police officers will do the needful to depute the additional police force.

Before parting, I am forced to say about Kannur District, from where several Writ Petitions came up apprehending violence, law and order problem etc. Kannur is one of the northern District in our State. It is generally states that, people of Kannur exhibit genuine hospitality, welcoming visitors with warmth and treating them like their family member, family rooted in strong community bonds and cultural values. I think that, in 2011 census, the overall literacy rate in Kannur District is above the average literacy rate in the State. Even then, why Keralites think that, Kannur is a place of political violence ? The entire Kannur people should awaken in this election and show to the entire State that it is a place where free and fair election is

conducted. The general public of Kannur and the entire machinery of police force in Kannur District should come forward to remove the bad label to the Kannur District. I leave it there.
