We are informed that the National Green Tribunal (NGT) has constituted a Committee viz., Yamuna Pollution Monitoring Committee comprising Ms. Shailaja Chandra and Mr. B.S. Sajwan as its members having its Office at Room No.58, India International Centre, 40, Max Mueller Marg, Lodhi Estate, New Delhi - 110 003. The said Committee is said to have made recommendations for improvement of quality of water in the Yamuna river.

We direct the aforesaid Committee to place its recommendations made for improvement of quality of water in the Yamuna river within a period of two weeks.
