UPON hearing the counsel the Court made the following

O R D E R

1. When this bunch of matters was taken up along with Writ Petition (Civil) Diary No. 36427/2024 and Diary No. 35840/2024, the Court Master placed an Office Report dated 19.08.2025 annexing therewith a copy of order dated 18.08.2025 passed by a co-ordinate Bench. In paragraph 8 of the Order dated 18.08.2025, it is observed

as follows:

"We are, however, completely taken aback at how the Registry of this Court functions while listing petitions invoking jurisdiction under Article 32 of the Constitution involving common issues. In listing such writ petitions, the Registry ought to follow either the 'coram rule' or the 'roster rule'. Placing writ petitions raising more or less common issues before separate Division Benches is beset with the risk of conflicting decisions being rendered which, having regard to the mounting arrears and the time constraints of the Court, should be avoided at all costs."

2. In light of the above observation, we deem it appropriate to direct the office to place the record of these petitions before Hon'ble the Chief Justice of India for an appropriate orders. The matters may be listed in accordance with the orders passed by Hon'ble the Chief Justice of India.
