3. The petitioners are hereby directed to furnish such of those documents as well as pen-drive to the respondents' counsel within two days.

4. Learned counsel for the petitioner, at this stage, submitted that 6th respondent is alleged to have violating the orders of this Court. If he is violating, he shall rectify himself, failing which suo moto contempt action would be initiated.
