The university actively fosters IPR research through initiatives such as the National Conference on "Navigating IP Challenges in the Digital Age: Focus on Artificial Intelligence and Emerging Technologies" and offers a Post Graduate Diploma in Intellectual Property Rights (PGDIPR) to empower graduates and professionals. By integrating robust academic programs, seminars, and workshops, RMLNLU not only upholds its commitment to high-quality legal education but also positions itself as a leader in bridging legal frameworks with emerging technological challenges in the domain of IPR.

ABOUT DPIIT-CHAIR

The Department for Promotion of Industries and Internal Trade (DPIIT), Ministry of Commerce and Industry, launched the SPRIHA scheme in 2016 to establish IPR Chairs in select universities and academic institutes. This aligns with the National IPR Policy's goal to strengthen IP Chairs in higher education for quality teaching, research, and curriculum development.

RMLNLU Lucknow was selected as one of the institutions to host an IPR Chair under the leadership of Professor Manish Singh. The Chair promotes IPR education, research, and outreach, offering courses at all levels and fostering policy-relevant research. It aims to create an IPR knowledge database, case study repository, and gather insights from industry and academia to aid policymakers. The initiative supports IPR application filings and encourages collaboration between industry and academia, addressing technology sharing and research gaps. Scholarships will also be provided for emerging IPR areas.

WORKSHOP THEMES AND OBJECTIVES

Theme 1: Intellectual Property Acquisition

- **Content:** Processes, strategies, and legal considerations involved in acquiring intellectual property through assignments, licensing, mergers & acquisitions, and technology transfers.
- **Target Group:** Law students, young practitioners, and professionals from business, management, and technology backgrounds interested in IP transactions.

assignment/licensing agreements.

- **Objective:** To equip participants with practical knowledge and skills for structuring and negotiating effective IP acquisition deals.

Theme 2: Intellectual Property Prosecution

- **Content:** Procedures and best practices for effective prosecution of patents, trademarks, and copyrights, including drafting responses to examination reports and managing office actions.
- **Target Group:** Law students and early-career professionals aspiring to specialize in intellectual property law and practice.
- **Format:** Expert-led sessions with case studies, followed by a practical drafting exercise on prosecution document.
- **Objective:** To equip participants with the skills to navigate prosecution processes before the IP offices and develop strategic, practitioner-level expertise in securing IP rights.

Theme3: Intellectual Property Licensing

- **Content:** Key concepts, structures, and negotiation strategies in IP licensing, including technology transfer, franchise agreements, software licensing, and royalty framework.
- **Target Group:** Law students aspiring to work in IP law, corporate law, or R&D-driven industries.
- **Format:** Expert lectures supplemented by case studies and a drafting exercise on sample licensing clauses.
- **Objective:** To equip participants with practical knowledge of IP licensing mechanisms and negotiation skills to structure effective and enforceable licensing agreement.

Theme 4: Intellectual Property Litigation

- **Content:** Fundamentals of IP litigation, including pre-litigation strategy, drafting of pleadings, interim reliefs, evidence in IP disputes, and analysis of landmark case law.
- **Target Group:** Law students, young advocates, and professionals seeking to build expertise in IP enforcement and litigation strategy.
- **Format:** Expert lectures followed by a case-study exercise simulating an IP dispute and courtroom strategy.
- **Objective:** To equip participants with practical skills in handling IP litigation like strategizing and drafting to effectively arguing IP disputes before courts.

Being an engineer, a patent agent she also has expertise in contentious proceedings, be it pre-grant or post-grant opposition proceedings before the Indian Patent office or revocation and appeal proceedings before the Courts.

She was actively involved in the amendment of Indian Patent Act, 2002. Since August 2006, she has been with the Council of Scientific & Industrial Research. She is currently a Senior Principal Scientist at CSIR-National Institute of Science Communication and Policy Research (NIScPR). She is also a regular faculty for Short-Term Courses on Intellectual Property Rights, conducted at CSIR. She has organised various programmes in the field of IPR as coordinator.

He completed his post-graduation from Rohilkhand University and has been awarded a Doctorate by the University of Lucknow. He is currently the Chair Professor of the Chair on Intellectual Property Rights (IPR) at Dr. Ram Manohar Lohiya National Law University, Lucknow, was established by the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India, in July 2024. He is also the Co-ordinator of “P.G. Diploma in Intellectual Property Rights” course of the University since its inception in 2017.

Dr. Manish has substantial academic work to his credit. As a distinguished academician, he has published a considerable number of research papers on the subject of Intellectual Property Rights in various reputed national and international journals.

He has a strong orientation towards Intellectual Property Laws. Specific area of his interest is Patent Law and Practice. He has guided various Research Projects/Dissertations on the Law of Patents.
