J U D G M E N T

Dated this the 23rd day of September, 2025

The petitioners are before this Court aggrieved by the indefinite suspension imposed upon them by the 7th respondent on 22.11.2024, evident from Exts.P6 to Ext.P8 as well as Exts.P13 to Ext.P15 orders. They are also aggrieved by the consequent act of not issuing Transfer, Conduct and Course Certificates as well as not forwarding their application for registration with the Kerala Nurses and Midwives Council, evident by Exts.P22 to Ext.P22(b) orders of the 7th respondent, despite the University granting Exts.P1 to Ext.P3 Degree Certificates. The petitioners are no longer students of the 6th respondent-College.

2. According to Exts.P22 to Ext.P22(b) orders of the 7th respondent, this Court, in Ext.P17



judgment, did not decide against Exts.P6 to Ext.P8 or Exts.P13 to Ext.P15 orders and the KUHS has also not taken a decision in the said matter. According to the 7th respondent, the request of the petitioners for issuing Transfer, Conduct and Course Certificates as well as forwarding their application for registration with the Nursing Council cannot be entertained since the police investigation in criminal case is still pending. On the other hand, the 4th respondent has passed Ext.P19 order, stating that the Board of Adjudication of Students Grievance (BASG) of University is not connected with the issuance of suspension against the petitioners and directed them to approach the 7th respondent-Principal since the suspension was ordered by the said office.

3. The Board of Adjudication of Students Grievance of KUHS has arbitrarily and without hearing the



petitioners passed the directions against the provisions of University Act and the First Statutes while adjudicating the representations directed to be considered by this Court in Ext.P17 judgment. The petitioners who had successfully completed BSc Nursing on 24.03.2025 have not been able to register with the Nursing Council till date and due to the same, the petitioners are put into a state of uncertainty and the circumstances warrant the intervention of this Court, contend the petitioners.

4. I have heard the learned Counsel for the petitioners and the respective Standing Counsel representing the respondents.

5. The petitioners were suspended pending disciplinary proceedings on certain charges alleged against the petitioners. In the meanwhile, the petitioners have completed their course. The petitioners now want to



register themselves as Nurses with the Kerala Nurses and Midwives Council.

6. The petitioners state that in view of the disciplinary proceedings, the College authorities are not issuing Course, Conduct and Transfer Certificates. These are all documents which are highly necessary for the petitioners for higher studies or for registering with the Kerala Nurses and Midwives Council.

7. As per Exts.P6 to P8 orders, the petitioners were suspended for an indefinite period. It is not disputed that the petitioners have now completed the course. If the petitioners have completed the course, ordinarily disciplinary proceedings are not proceeded with further. In view of the initiation of disciplinary proceedings, the College authorities will not be justified in withholding Certificates / mark list etc. deliverable to the petitioners.
